#### 1. Opening

 Hanneke opens the meeting by announcing that it will focus on renewing the collaboration within DigiShape.

# **3.** Multiannual plan 2024-2027 + yearplan 2024 - appendix 3

(decision)

Chris explains that the joint discussion about recalibrating and refining the strategy has led to a multiyear plan that gives direction to the collaboration in the coming years. On the last page, the goals for this year are displayed: the 2024 annual plan.

The plan is discussed, answering some questions:

- New thematic areas can be introduced over time as an organic process. If partners feel a need to work on a new topic and this topic gains enough traction, it may become a new theme.
- Sharing of data is not explicitly mentioned in the cooperation agreement, but it is a key element of the multi-annual plan. The TO2 DigiLab project was mentioned as a means to accelerate datasharing within DigiSHape. Partners stress the importance of making DigiShape a partner in the TO2 DigiLab final proposal.
- The DigiShape Core-team stresses that it is important that partners strive to connect all their relevant activities to DigiShape. Only then we can create the impact we are looking for as a network initiative. Potentially relevant cases can be discussed with Chris to see if and how we can involve the DigiShape partners and community.

#### 4. Renewal of the cooperation agreement '24 - '27

Hanneke explains that many partners have now expressed their intention to continue the cooperation within DigiShape in a new strategy period. In this agenda item, we will go over the final issues with each other in order to sign the new cooperation agreement in March.

- Budget 2024 en partner contribution adjustment (decision)

  During the previous partner meeting it was decided to grant the in-kind partner contribution as a rebate if a concrete contribution was actually made. The core team was asked to elaborate on this, also in light of the annual budget. Some partners re-open the discussion about the decided approach to the partner contribution, as it might for some partners lead to unfavourably high cash contributions, ultimately leading to the need to leave the partnership. The core-team is requested to come up with an intermediate proposal, applying the same groundrules for all partners, and approach all partners for their approval in the coming weeks.
- **Signature SOK** (decision)
  In the previous partner meeting it was decided not to make any substantive changes to the cooperation agreement. The proposal is for each partner to sign the SOK for themselves, after which the SOK will be digitally compiled with the signature pages of all partners. All partners agree
